Too Much Turkey Is No Excuse for Not Buckling Up

Special Click It or Ticket Enforcement Mobilization November 15 through November 28, 2010 Aimed at Increasing Seat Belt Use and Saving Lives

San Jose, CA -- With the holidays upon us and millions of Americans hitting the roads, the San Jose Police Department wants everyone to arrive safely at their destinations. Drivers and passengers need to know that officers will be out in force sending the strong message to "Click It or Ticket."

"No one wants to start the holidays off with a ticket," said Acting Chief Chris Moore, of the San Jose Police Department. "We want everyone to enjoy a safe holiday season with loved ones -- don't throw it away simply because you failed to buckle up."

While seat belt use is at a record high of 83 percent nationwide, 45 million Americans still fail to buckle up when they get in a motor vehicle. Although 96.2 percent of California motorists and passengers use their safety restraints, over 1.5 million Californians don't buckle up.

During the holiday period, over 35 unrestrained vehicle occupants will be killed in motor vehicle crashes each day nationwide. <u>Statewide, overall traffic deaths declined by 23 percent, from 3,995 in 2007 to 3,081 in 2009</u>, due in part to the increased use of seat belts. <u>Total Traffic fatalities are at their lowest levels in six decades</u>.

"Sadly, the holiday, which for many are the happiest time of the year, is also one of the deadliest and most tragic," said Chief Moore.

"Regular seat belt use is the single most effective way to protect people and reduce fatalities in motor vehicle crashes," said Christopher J. Murphy, Director of the California Office of Traffic safety. "Law enforcement estimates indicate that over 1300 Californians survived by buckling up last year. Sadly, however, about 150 others will not be gathering with families during the holidays because they choose not to use their seat belts."

National statistics also show that those least likely to buckle up are teens, young adults, males, nighttime riders, motorists traveling on rural roads, and individuals traveling in pick-up trucks.

More than 100 local law enforcement agencies statewide and the California Highway Patrol (CHP) will be participating in this year's Click It or Ticket mobilization. Funding to support California's Click It or Ticket campaign was provided by a grant from the California Office of Traffic Safety (OTS) through the National Highway Traffic Safety Administration (NHTSA).

San Jose: On 10/30/10, approximately 2:00 a.m., the victims observed an unknown male adult beating and dragging a female adult on South First and Devine streets. The victims attempted to intervene and assist the woman, at which time the suspect turned and assaulted both victims.

Both victims sustained serious facial lacerations and head trauma and were knocked unconscious for approximately 15 minutes as a result of the assault. A passerby found both victims unconscious and notified the San Jose police; the suspect and woman were gone when the passerby came upon the scene. San Jose: On Friday, 11/5/10, 7:16 a.m., the San Jose Police Department received a report of a kidnapping. The caller, a relative of the victim, reported the victim had left his home the previous evening, Thursday, 11/4/10, around 9:00 p.m. to run errands. This was not considered unusual for the victim, as the victim is a local food business owner and is known to check his business establishments during the evening hours.

The victim failed to return home at the expected time, prompting family to call the victim's cellular phone around 12:30 a.m. However, the victim's phone apparently was turned off and the call went directly to voice mail. This in itself was unusual, as the victim habitually maintains his cellular phone turned on and is known to answer all calls.

At approximately 1:15 a.m., Friday, 11/5/10, the victim's family received a call from the one of the suspects, demanding \$1 million ransom by 6:00 a.m. for the safe return of the victim. The victim's family delayed calling the San Jose Police Department until 7:16 a.m., at which time a team of officers were assigned to the investigation from the Patrol Division; Special Operations -- Mobile Emergency Response Group and Equipment (MERGE) and METRO; Bureau of Investigations -- Robbery, Assaults, Gang

Investigations, and Homicide units initiated an intensive and widespread investigation into the victim's kidnapping.

The police investigation continued throughout the day with officers coordinating their various investigative methods at various locations throughout the city. These concerted investigative efforts allowed officers to develop leads and information that subsequently revealed the victim was being held captive in the 1100 block of Fargate Circle in San Jose.

Officers responded to the 1100 block of Fargate Circle and observed a vehicle leaving the house where the victim was being held. Officers conducted a high-risk vehicle stop of the suspect car and took the driver and one passenger into custody at approximately 8:13 p.m.

Officers obtained information from the driver and passenger of the suspect vehicle which confirmed the victim was alive and being held in a two-story residential dwelling of the 1100 block of Fargate Circle.

Officers continued to surveil the house where the victim was being held and observed two males exit the house. Officers acted promptly and took the two subjects into custody without incident.

Officers obtained additional information from both suspects, which confirmed the victim was being held captive in the house while bound with duct tape. Officers also learned of a fifth suspect who was armed and had remained in the house to monitor the victim.

Shortly after officers arrested the two subjects that had exited the house, a male subject was observed jumping out a second story window from the house where the victim was being held. Officers contacted the subject who had jumped out of the window and determined it was the victim.

Officers moved the victim to safety and promptly took the fifth suspect into custody without incident at approximately 10:11 p.m.

The victim had sustained non life-threatening injuries inflicted by his captives and also sustained non life-threatening injuries as a result of jumping out of the second story window. Investigation revealed the suspects had assaulted the victim using an electric stun device. The victim was taken to a local hospital where he was admitted with non life-threatening injuries.

Additional investigation following the rescue of the victim and arrest of the suspects revealed controlled substances in the victim's home.

The motive remains under investigation and it is unknown whether the suspects targeted the victim in connection with his illicit drug activity.

The suspects were booked into the Santa Clara County Jail on various charges, including Kidnapping for Ransom and Robbery.

A total of approximately 125 officers were utilized to investigate this case due to the severity and nature of this crime. These included officers from the aforementioned specialized units and all three patrol division shifts.

The San Jose Police Department has been awarded a new traffic safety grant for a year-long anti-DUI program aimed at preventing deaths and injuries on our roadways. Additional enforcement measures in place to combat impaired driving are coming as a result of a recent \$382,259.00 grant awarded by the California Office of Traffic Safety to City of San Jose. The San Jose Police Department is dedicated to keeping our streets safe through both enforcement and education.

"As a long time partner with the Office of Traffic Safety, the San Jose Police Department looks forward to this renewed effort toward enforcement of driving under the influence laws. We recognize that on average three people die every day in California as a result of this dangerous activity. During our 2010 DUI campaign, we hope that through awareness, education and enforcement we can continue to help reduce collisions and the resulting tragedies that are caused by drivers operating a vehicle under the influence of drugs or alcohol," said Chief Rob Davis, San Jose Police Chief.

The special DUI Enforcement and Awareness grant is geared to assist efforts to reduce the number of persons killed and injured in alcohol and other drug-related collisions in the community. The grant activities will specifically target impaired driving offenders as well as educate the public on the dangers of impaired driving. This will be accomplished through the use of DUI/driver's license checkpoints and saturation patrols.

Imparied / Drunk driving is one of America's deadliest crimes. In 2009, over 10,839 people died in highway crashes involving a driver or motorcycle operator with a blood alcohol concentration (BAC) of .08 percent or higher. California data for 2009 shows that 950 died in Alcohol Impaired Collisions, a 7.6 percent reduction in deaths from 2008.

"Everyone in California should be heartened with these figures," said Christopher J. Murphy, Director of the California Office of Traffic Safety (OTS). "But as encouraging as this is, we can't let up on the efforts to promote and enforce traffic safety. Far too many are still losing their lives or being severely injured on our roadways.

"These figures represent more people making it home safely and alive each day," said Murphy. "But to keep this trend going, we will continue to strive to meet our vision -- *Toward zero deaths, every 1 counts*."

The San Jose Police Department is conducting an investigation into an officer-involved shooting incident that occurred earlier this morning. The investigation is being monitored by the SJPD Internal Affairs Unit, the Santa Clara County District Attorneys Office and the Office of the Independent Auditor. The preliminary investigation has revealed the following.

On Thursday, October 21, 2010 at approximately 1:50 a.m. a San Jose Police Officer attempted to stop a subject for a California vehicle code infraction in the area of Cunningham Ave. and Nassau Dr. in San Jose. The vehicle sped away, but the officer was able to obtain a license plate number. Officers checked police data bases and learned that the registered owner of the vehicle had a half-a-millions-dollar felony warrant for an attempted murder. Officers determined that the wanted suspect had allegedly stabbed his father multiple times in July 2010 in San Jose. The suspect had a very violent criminal history. Officers obtained a photograph of the suspect wanted for the attempted murder and the officer who originally attempted to stop the vehicle verified that the subject driving the car he tried to stop was the same person.

Officers circulated the area in an attempt to locate the vehicle and suspect. At approximately 4:08 a.m. officers located the vehicle with the suspect sleeping in it within one mile of the original attempted car stop in the area of Seminole Way and Tampa Way in San Jose. Multiple officers were called to the area and a supervisor and officers developed a tactical plan to safely take the suspect into custody that would not allow him to flee again or be a danger to others.

The officers surrounded and blocked the suspects vehicle with patrol vehicles. Officers got on a patrol car Public Address (PA) system and started issuing commands to the suspect. The suspect put the car into gear and drove forward into a patrol car that had been pulled in front of his vehicle to block him in. Officers continued to issue commands to the suspect and he failed to comply. An officer started approaching the vehicle and the suspect responded by shooting a large caliber handgun that had an increased capacity magazine. Numerous officers returned fire. Officers could see the subject still moving around in the car and continued to order the suspect out of the car and he would not comply. Officers started evacuating residents from the immediate area and SJPD Special Operations Units were called-out from home and responded to the scene with tactical negotiators. The suspect continued to refuse to leave the vehicle. A robot was utilized to approach the vehicle and officers were able to extract the suspect from the car at approximately 8:40 a.m. and transport him to a local hospital for medical care.

The officer who initially approached the vehicle was transported to a local hospital and treated and released for minor injuries to his face and a minor injury to his leg.

The three rescuers braved hazards presented by the burning car and downed power lines to extricate the victim from the wreckage and to save him from fatal injury.

Much discussion is taking place across the country concerning what responsibility local police departments have to ensure compliance with immigration laws. While the San Jose Police Department stands ready to work with any law enforcement agency to pursue violent suspects, regardless of a suspect's immigration status, the Department has a longstanding policy of not arresting persons based solely upon their failure to comply with Federal immigration laws. This longstanding policy was reaffirmed by the San Jose City Council on March 6, 2007, through its adoption of Resolution No. 73677, which states, in part:

"The City of San Jose has a strong interest in assuring that legal and undocumented immigrants do not fear interacting with their local governmental authorities. In past years, the City has seen how the reluctance of immigrants to interact with local authorities can critically undermine the health and safety of our community. For example, the failure of victims to report crimes, the reluctance of witnesses to cooperate with the police, or the unwillingness of parents to take children to school or to a health clinic, can have grave impacts on the well-being of all of San Jose's residents, including U.S. citizens.

The city of San Jose reaffirms the San Jose Police Department's longstanding policy that its officers will not arrest persons merely for their unlawful presence in the United States; that no otherwise law-abiding undocumented immigrants should fear arrest or deportation for coming forward to report a crime as a victim or witness; and that no otherwise law-abiding undocumented immigrants should fear arrest or deportation by contacting any employee of the city of San Jose to express concerns or to ask questions. Moreover, the City of San Jose maintains that Immigration and Customs Enforcement (ICE) raids -- while laudable where they target violent or predatory criminals for deportation -- can have harsh and unintended consequences. Those sweeps that have cast the net widely to arrest otherwise law-abiding undocumented immigrants have raised the Council's concern, insofar as they undermine the ability of our police, fire department, and other city agencies to interact with fearful immigrants, leaving all of San Jose's residents less safe."

The San Jose Police Department recognizes the value of maintaining the community's trust, and it is only by doing so that the Department is able to partner with the community to garner cooperation and provide the highest quality of service and protection to all community members, regardless of immigration status.

- Keep alert by focusing on the road and avoid distractions such as cell phones.
- Expect children to pop up in the wrong place!
- As a driver, the two most important things you can do to improve safety for our kids is to SLOW DOWN and PAY ATTENTION, especially in school zones.

Teach the children in your life to:

- Walk on the sidewalk, not in the street.
- Look ALL ways before crossing the street.

Vicente operated ADEK Financial, Inc., a financial and investment advisory business, and maintained offices in Fairfield, Concord, Colma, and San Jose. Vicente targeted the Spanish-speaking community and defrauded thirty five victims of 2.2 million dollars in a Ponzi scheme in 2006 and 2007, with promises of high profit returns.

Vicente regularly held live radio broadcasts on local Spanish radio stations, where he advertised his business and attempted to lure victims to invest their money through his company. As Vicente failed to gain additional victims to sustain his scheme, he attempted to convince existing victims to reinvest

their money through his company for an additional year. However, after failing to lure additional victims to invest and passing nonsufficien funds (NSF) checks to existing victims, Vicente closed his business, and all offices, at the end of 2007.

Prior to Vicente closing his business, some of the victims received partial payment of their investments; however, most victims were not reimbursed any of their investment, prompting the thirty five victims to collectively report Vicente to the police in early 2008.

Investigators with San Jose Police Department's fraud unit arrested Vicente at his place of employment in San Jose without incident, where he was employed in an unrelated field.

Following an investigation by the San Jose Police Department, the Santa Clara County District Attorney's Office Elder Fraud Unit has issued a criminal complaint charging ex-Bank Manager John Tran, formerly of Wells Fargo Bank in San Jose, with several charges including Theft from an Elder, Grand Theft and Forgery.

From March 2008 to February 2009, Tran was a manager at Wells Fargo Bank on Lincoln Avenue in San Jose. Tran befriended several elderly clients, and even made visits to their homes. Unbeknownst to the clients, in February 2009 his employment with the bank ceased, yet he continued visiting some of the bank's customers. In some instances, Tran convinced elderly customers to invest in certain CDs, only to pocket the money himself through an elaborate money-laundering scheme. In other instances, Tran forged signatures of bank customers, including recently deceased senior citizens, and simply drained their bank accounts. Tran is alleged to have structured over \$900,000 in suspicious transactions. Tran was arrested on March 10, 2010.

"Summertime Safety"

DETAILS:

With summer vacation under way, the San Jose Police Department and the Family Violence Unit want to remind parents, guardians and babysitters to take extra care with little ones this year. Tragic reminders surround us every day:

In 2006, San Jose Police Officers investigated 15 cases of children falling out of second-floor windows. There have been 3 such cases since January 2008;

Officers have responded to numerous complaints from concerned citizens about children left in locked cars in sweltering heat;

In the past several years, San Jose Police Officers have investigated numerous drownings or near-drownings of children, some as old as 11 years of age, in bathtubs and home or apartment swimming pools. There have been 6 such cases since January 2008;

In April 2002, San Jose Police Officers removed two small children, one 3-years-old and one 10-months-old, who were locked in a car. The officers estimated the interior temperature of the vehicle to be 100 degrees. The father was shopping at a nearby commercial center.

In May 2000, San Jose Police Officers removed a two-year-old from a car when the child was found by a passer-by. The childs mother was shopping at Eastridge Mall in east San Jose.

In June 2000, San Jose Police Officers removed a three-year-old from a car when the child was found by a passer-by. The outside temperature was 83 degrees and the inside temperature of the car was well over 100 degrees. The childs mother was shopping at Westgate Mall in west San Jose.

Also, California law requires persons under 18 years age to wear a safety helmet while bicycling, roller skating, rollerblading, or riding a non-motorized scooter. Persons under 18 years of age must also wear a safety helmet while riding as a passenger on a bicycle, non-motorized scooter, or skateboard. This requirement also applies to a person who rides upon a bicycle while in a restraining seat that is attached to the bicycle or in a trailer towed by the bicycle.

Many of these cases have resulted in criminal charges being filed against the parent or guardian. The most tragic scenario is a parent, guardian or babysitter living a lifetime of regret over an injury or death that could easily have been prevented.

The San Jose Police Department reminds parents, guardians and babysitters to make good decisions this summer. Know where your children are. If you have to leave them, even momentarily, make sure that someone else is watching them for you. It takes only an instant to change a young life, or yours forever.

Three Arrested in Connection with Willow Glen and South San Jose Home Burglaries

San Jose: San Jose Police investigators have arrested three suspects believed to be connected to at least 30 residential burglaries in San Jose, most of which occurred in the Willow Glen and Santa Teresa areas. The break-ins took place from approximately early January through May of 2010. During that time, witnesses provided police with descriptions of suspects and one vehicle, described as a silver older American-made four-door sedan.

A break in the case occurred on Tuesday, May 4, 2010 at approximately 1120 hours, when a caller to the San Jose Police Department reported that several individuals appeared to be trying to burglarize homes near Lincoln Ave. and Broadway Ave. in the Willow Glen area. When officers arrived, they determined that the suspects had left the scene. Officers immediately obtained and broadcast over the police radio a description of the suspects and their vehicle, which matched the descriptions provided by earlier witnesses.

Over the next several minutes, officers observed the vehicle in motion on two separate occasions but could not get close enough to safely make an enforcement stop due to traffic conditions on and around Lincoln Ave. They were, however, able to determine that

there were three occupants inside the vehicle.

At approximately 1129 hours, an officer saw the suspect vehicle

parked and unoccupied in front of a residence in the 900 block of Northrup St. in San Jose, which is about 2 blocks from the location of the original burglary-in-progress call. Officers made contact at the residence and a female adult, later identified as 20-yearold Shalita Bolden, answered the door. Following an investigation, officers were able to associate Bolden with the suspect vehicle, and upon searching the vehicle, officers located stolen property inside. During a search of Bolden's residence, investigators recovered additional stolen items.

Suspect Shalita Bolden was arrested for PC 496, buying or receiving stolen property, and was booked into the Santa Clara County Jail. Detectives later determined that Albert Charles Bolden, the brother of Shalita Bolden, had also been an occupant of the vehicle at the time it was observed by officers. Investigators immediately began searching for Albert Bolden and conducting surveillance on multiple locations that he had been known to frequent. Meanwhile, another residential burglary occurred in the Edenvale area of San Jose on Monday, May 24th. Numerous firearms were taken from the residence. Evidence collected at the scene linked suspect Albert Bolden to the break-in.

The next day, a resident of Amby Dr. in San Jose called police to report two males climbing over her neighbor's fence. Patrol officers quickly arrived on the scene and took the pair into custody. One of those captured was Albert Bolden. The second suspect was 22-year-old Lamarcus White. Detectives believe these suspects and possibly others--either working together or alone--may be linked to more than 30 residential burglaries in San Jose. Subsequent investigation led to the recovery of all the firearms taken during the May 24th burglary.

The three suspects are charged with the following crimes:

Shalita Bolden: Four counts of buying or receiving stolen property.

Albert Bolden: Ten counts of burglary, one count possession of a controlled substance, and one count of possession of less than one ounce of marijuana.

Lamarcus White: Two counts of burglary.

Investigators say the assistance of residents was invaluable and helped lead to the capture of the suspects. Neighbors not only recognized and immediately reported suspicious activity in their neighborhood but also provided police with accurate suspect and vehicle descriptions.

It is important to note that these burglaries occurred at unoccupied homes during the daylight hours and most were categorized as "open or unlocked." That is, the burglar simply walked or climbed through a door or window left open or unlocked by the resident. Burglars are opportunists who search for an easy target, and many break-ins can be prevented simply by closing and locking all doors and windows before leaving home, even during the warm summer months. In addition, getting to know your neighbors and organizing a Neighborhood Watch program is an excellent way to prevent crime in your neighborhood.
