Detectives have identified the above homicide victim as **John Nguyen**. The investigation is on-going and there have been no new developments.

**San Jose:** On Tuesday, June 14, 2011, at 3:06 AM, San Jose police responded to reports of an unknown disturbance in the 1200 block of Oxton Drive. When officers arrived, they located the victim, who had been fatally shot. The unidentified suspect(s) had fled the scene prior to the arrival of officers and remain at large.

Moments later, police were notified of three additional gunshot victims stemming from this incident who had walked into local hospitals seeking medical attention. All three victims were treated and released for non-life-threatening gunshot wounds.

The investigation revealed the victims were attending a gathering inside the garage of a residence when one or more suspects walked up and opened fire. The motive and circumstances of the shooting are unknown and remain under investigation. No arrests have been made in this case and it is unknown whether this homicide is gang-related. There are no further details at this time and updates of new developments in the investigation will be issued, as that information becomes available.

This marks San Jose's 25th homicide of the year.

**San Jose:** On 6/18/2011, at approximately 5:12 A.M., San Jose Police Officers received an aid request from the Santa Clara County Sheriff's Office, who had deputies in pursuit of a fleeing vehicle. As officers responded, it was broadcast that the fleeing vehicle had crashed in the area of Highway 101 and East Santa Clara Street. Officers responded to that area and located the collision. AMR responded and pronounced the driver of the fleeing vehicle, Jesus Loera, dead at the scene at approximately 5:30 A.M. AMR transported the truck's passenger to Regional Medical Center where he is currently being treated for his injuries.

Preliminary investigation into the collision revealed that the suspect vehicle was attempting to evade Santa Clara County Sheriff's Deputies at the time of the collision. The suspect vehicle was travelling westbound on Alum Rock Avenue at a high rate of speed. The suspect vehicle continued over the Highway 101 overpass toward East Santa Clara Street, when it struck a commercial tanker truck's tank broadside. The suspect's truck travelled underneath the tank, shearing off the top of the truck. The suspect vehicle then struck a nearby building causing major damage to the building. The tanker truck's tank was empty at the time of the collision. The driver of the tanker truck was not injured.

The San Jose Police Department's Traffic Investigation Unit responded to conduct the collision investigation. Matters pertaining to the circumstances surrounding the vehicle pursuit will be handled by the Santa Clara County Sheriff's Office.

This incident marks San Jose's 14th traffic fatality of 2011. Five of the fourteen fatalities involved pedestrians.

The San Jose Police Department's Robbery Unit is seeking to identify a suspect believed to be responsible for at least 20 armed robberies in the bay area. On Sunday, June 12th of this year, the suspect committed a robbery in the 1100 Block of Lincoln Avenue in San Jose.

Preliminary investigation into the armed robbery revealed that the suspect entered the store, brandished a handgun at the employees, and demanded money. The suspect fled the store on foot with an undisclosed quantity of cash and remains at large.

Detectives believe that the suspect is responsible for similar robberies in the following cities: San Francisco, San Leandro, San Bruno, Redwood City, Pacifica, Menlo Park, Fremont, Daily City, Colma, and now San Jose.



This suspect is considered to be armed and dangerous. #### San Jose:

On Wednesday, June 15th of this year, in Chicago, Illinois, the San Jose Police Department was honored by *Connected World* magazine for technology innovation. Recipients of the award had to have utilized technological resources, strategies, and tacticss to overcome their particular organizational challenges. Recipients were judged on individual merits and the extent to which they met several criteria, including the benefit to the overall business practices and productivity improvement. The San Jose Police Department received the Gold Award, which was the highest award given at the ceremony.

The San Jose Police Department conducted a pilot program utilizing a CIRA (Cellular Internet Routing Appliance) box which was attached to police vehicles. This device was equipped with a Wi-Fi router, allowing officers to connect laptop computers as well as e-citation and mobile fingerprinting devices over a local wireless network centered in their patrol vehicle. This enabled officers to remove the laptop computers in their cars and write reports outside of their vehicles. Officers also had the ability to monitor field events on the laptop from outside their patrol vehicles.

The device also provided two-way mobile broadband connection with police headquarters as well as GPS capabilities. San Jose: San Jose police have arrested three suspects in connection with the March 23 murder of Jeffery Melanio in the 900 block of Lundy Avenue.

Billy Nguyen, 22, of San Jose, has been formally charged with homicide and currently is in custody at the San Quentin State Prison in Marin County on a parole violation. Billy Nguyen is pending extradition to Santa Clara County for criminal proceedings.

Jimmy Nguyen, 24, and Huy Van Nguyen, 23, both of San Jose, have been arrested for accessory after the fact for their part in knowingly aiding the suspects evade arrest and prosecution.

An arrest warrant for Jaime Lyuanta Soth, 24, of San Jose, has been issued for homicide. Soth is considered armed and dangerous and remains at large.

Billy and Jimmy Nguyen are siblings, and they're cousins to Huy Van Nguyen. Jaime Soth is a friend of the three.

### BUCKLE UP DAY AND NIGHT

#### One Million Californians Still Not Buckling Up

San Jose, Calif. -- As families across California plan for upcoming spring travel, there's not much you can do to control the cost of filling up the gas tank, but you can avoid a costly ticket by making sure that everyone in the car wears their seat belt. Law enforcement throughout the state, including San Jose Police Department will be looking for unbelted drivers and passengers as part of the 2011 Click It or Ticket mobilization, May 23 -- June 5. The fines and fees for first time adult seat belt violations is a minimum of \$142. For children under 16, the fine is \$445 for a first time offense.

Because nighttime passenger vehicle occupants are among those least likely to buckle up and most likely to die in crashes when unrestrained, nighttime enforcement has become a priority of the Click It or Ticket mobilization. Nationwide, of those who died in nighttime crashes in 2009, nearly two-thirds (62 percent) were not wearing seat belts at the time of their fatal crashes.

"Many nighttime traffic deaths can be prevented if more motorists simply start wearing their seat belts. Law enforcement throughout the area will be looking for seat belt violators, day and night," said Police Chief Moore. "Citations will be issued without warning. It's not just about avoiding a costly ticket; it's about keeping the ones you care about alive. Remember to buckle up on every trip, day and night."

California's current seat belt use rate of 96.2 percent is at an all- time high, but that still leaves nearly one million people who are not buckling up, putting their lives at risk every time they get into the car. The Click It or Ticket mobilization is credited with increasing the state's adult seat belt usage rate from 92.5 percent in 2005 to 96.2 percent in 2010.

"We are very proud of California's seat belt and child safety seat use rates," said Christopher J. Murphy, Director of the California Office of Traffic Safety. "However, with nearly one million motorists still not buckling up, there is much more work to do. Reaching the last four percent of motorists is crucial to reaching our goal of zero deaths."

More than 600 permanent Click It or Ticket highway signs, which have been up since 2005, have been updated to reflect the 'Minimum \$142' message as a reminder to motorists that failing to buckle up is costly.

Properly restrained drivers, passengers and children have a 50 percent better chance of surviving a crash than unbelted occupants. Those ejected from vehicles in crashes or roll-overs are up to 35 times more likely to die than restrained occupants. In 2009 alone,

seat belts saved approximately 12,713 lives nationwide. In California, it is estimated that 320 people who were killed in 2009 would be alive today if they had been wearing seat belts.

More than 140 local law enforcement agencies statewide and the California Highway Patrol will be participating in this year's Click It or Ticket mobilization. Funding to support California's Click It or Ticket campaign was provided by a grant from the California Office of Traffic Safety through the National Highway Traffic Safety Administration.

**San Jose:** On May 10, 2011, at approximately 2:47 PM, San Jose police investigated a reported stabbing at a residence in the 1700 block of Kyra Circle. The victim suffered multiple stab wounds and was taken to Regional Medical Center, in San Jose, where he was hospitalized with life-threatening injuries.

Witnesses reported seeing the suspect flee the scene in a white 2005 GMC pickup truck prior to the arrival of officers. Investigators identified the suspect and a warrant for his arrest was obtained. The suspect's vehicle and license plate numbers were also identified and entered into a nationwide "wanted persons" database.

On May 11, 2011, at approximately 3:30 PM, the suspect reportedly fell or jumped from a highway overpass onto U.S. Route 101 in Carpinteria (Santa Barbara County). The victim was taken to Santa Barbara Cottage Hospital, in Santa Barbara, where he currently remains hospitalized with undisclosed injuries.

During their investigation, Santa Barbara County sheriff's deputies located the suspect's pickup truck and, after checking the license plate, learned the suspect was wanted for stabbing the victim in San Jose.

Santa Barbara County sheriff's deputies placed the suspect under arrest on the San Jose warrant, while still hospitalized at Santa Barbara Cottage Hospital, and notified San Jose police assault investigators.

On May 12, 2011, at approximately 11:50 PM, the victim succumbed to his injuries and died while hospitalized at Regional Medical Center.

With the victim's passing, the case is now being investigated by the San Jose Police Department's homicide unit. Investigators have determined the victim and suspect were acquainted with one another. The motive remains under investigation.

Homicide investigators will coordinate the transfer of the suspect to the Santa Clara County Jail once his medical condition permits, to face potential criminal charges.

This marks San Jose's nineteenth homicide of the year.

## HUMAN TRAFFICKING AWARENESS VIDEO TO RUN IN SOUTH BAY MOVIE THEATERS BEGINNING APRIL 1st San Jose Police, partners, create and launch video to educate movie-goers about modern-day slavery

In an effort to raise the public's awareness of modern-day slavery, the San Jose Police Department's Human Trafficking Task Force, working with the South Bay Coalition to End Human Trafficking, the Santa Clara County District Attorney's Office and federal agencies, will begin showing a 60-second video in South Bay movie theaters on April 1st. The public service announcement encourages persons to take action if they suspect a human trafficking situation by phoning the National Human Trafficking Hotline (1-888-3737-888). The campaign is made possible through a grant from the United States Department of Justice / Bureau of Justice Assistance.

The awareness campaign will run for 12 weeks, in 13 theaters, on over 90 screens, including the Eastridge Mall 15, Mercado 20, Oakridge 20, Salinas Northridge Mall 14, and Santa Cruz 9.

Since 2005 the SJPD task force has partnered with the South Bay Coalition to End Human Trafficking to identify and rescue victims of trafficking, provide comprehensive services to trafficking survivors, train law enforcement, and increase the public's awareness of trafficking. The task force and coalition bring together federal and local law enforcement agencies with victim-services professionals to provide a multi-disciplinary response for trafficking victims in the four South Bay counties; Santa Clara, Santa Cruz, San Benito, and Monterey.

The video was designed by SJPD Police Artist Gil Zamora, and features original music and lyrics by San Jose musician Alyssa Rose.

The issue of modern-day slavery has been a focus of the U.S. Department of Justice since 2000, when Congress passed the Trafficking Victims Protection Act. The act defined trafficking as the obtaining of labor, or the act of commercial sexual exploitation, of a person through force, fraud, or coercion. A grant program created in 2005 funds 40 collaborative efforts nationwide. According to the 2010 Trafficking in Persons Report, issued by the Department of State, 12.3 million people are held in forced or bonded labor, or forced prostitution, worldwide.

According to South Bay Coalition to End Human Trafficking chairwoman Perla Flores, "Under the Trafficking Victims Protect Act, victims are guaranteed certain rights and services, such as immigration benefits, medical services, and pro bono or low-cost legal assistance. Working with the South Bay Coalition to End Human Trafficking, we are able to assist victims in reclaiming their inherent rights to safety, security, and hope."

The South Bay Coalition to End Human Trafficking is a collaborative of local victim-services providers including the Katharine and George Alexander Community Law Center, Next Door Solutions to Violence, Community Solutions, the YWCA of Silicon Valley, and others, and is funded through a grant from the U.S. DOJ / Office for Victims of Crime.

Law enforcement task force members include the San Jose Police, FBI, ICE, the Santa Clara County District Attorney's Office, the United States Attorney's Office, and the United States Department of Labor.
