San Jose: The San Jose Police Department is investigating an officer involved shooting that occurred on September 24, 2015.

On Thursday, September 24, 2015, at 6:34 p.m., San Jose Police officers were dispatched to the 6100 block of Monterey Rd. on a welfare check on Suspect Woods who was threatening to kill himself.

Officer Morales located Woods in the area of Monterey Rd., north of Southlake Dr. Officer Morales made contact with Woods. Woods approached the right front passenger side of the vehicle and made a comment that he wanted Officer Morales' gun. Officer Morales exited his vehicle and made contact with Woods. Woods then reached into the police vehicle through an open window and began ransacking a bag on the front passenger seat. Officer Morales began giving him commands; however, Woods did not comply. Officer Morales used his Taser on Woods which had little effect.

Woods then advanced towards Officer Morales. Officer Morales backed away and sprayed Woods with his OC Spray. However, the spray had minimal effect on Woods and he continued to ignore commands.

Woods then moved onto the street towards the open driver's door of the police vehicle. Woods reached into the police vehicle, grabbed the shotgun and attempted to remove it from the shotgun rack. Officer Morales gave the suspect commands to exit the vehicle and get on the ground, but he continued to pull on the shotgun. Officer Morales believed Woods had successfully grabbed the shotgun and he shot Woods as he turned towards him.

Woods went to the ground. Other officers arrived on-scene and Woods continued his failure to comply with officers commands and attempted to get up. Another officer shot a 40mm less lethal round at the suspect. An arrest team was formed and Woods was taken into custody.

San Jose Fire Department and EMS personnel treated Woods on-scene. Woods was transported to a local hospital with at least one gunshot wound. Woods is listed in stable condition with non-life threatening injuries.

Woods was turned over to the custody of the Santa Clara County Department of Correction to be booked into the Santa Clara County Jail for 148 (d) PC - attempting to take a firearm from the presence of an officer and 664/487 (d)(2) PC - attempted grand theft of a firearm.

Officer Morales was placed on paid administrative leave. This is the City's ninth officer involved shooting of 2015.

The SJPD Homicide Unit is conducting the criminal investigation. The case is being monitored by the SJPD Internal Affairs Unit and the Santa Clara County District Attorney's Office.

The San Jose Police Department Will Be Out In Full Force To Catch Drunk Drivers



As summer winds down, the San Jose Police Department is ramping up its enforcement efforts as part of a national crackdown on drunk driving. The 18-day, high-visibility campaign, *Drive Sober or Get Pulled Over,* is a partnership with the California Office of Traffic Safety to curb impaired driving and save lives. August 21-September 7 (Labor Day), law enforcement partners in Santa Clara County, across the state and nationwide will show zero tolerance for drunk driving. Increased state and national messaging about the dangers of driving drunk, coupled with checkpoints and increased officers on the road, aim to drastically reduce the toll of drunk driving.

And what a toll it is. In 2013, there were 10,076 people killed in drunkdriving crashes, almost a third of all traffic fatalities according to the National Highway Traffic Safety Administration (NHTSA). In California, 867 died in drunk driving collisions according to NHTSA. Thirty-eight percent of crash fatalities on Labor Day weekend that year involved drunk drivers with a Blood Alcohol Content (BAC) of .08 percent or higher. And were not just talking about a little bit of alcohol, either. More than a quarter (27 percent) of the crash fatalities that occurred on Labor Day weekend involved drivers with BACs of .15 or higher almost twice the illegal limit.

The San Jose Police Department kicks off the enforcement period with a DUI/Drivers License checkpoint scheduled for Friday, August 21st. Several special DUI Saturation Patrols will also be conducted throughout the campaign ending September 7th.

NHTSA data shows that repeat offenders are an especially dangerous facet of the drunk-driving problem. In the month of August from 2009-2013, of the drunk drivers involved in fatal crashes, almost 1 out of 10 (8 percent) of them had already been convicted of at least one drunk-driving offense.

Law Enforcement emphasizes the preventable nature of drunk driving reminding everyone that all it takes is a little planning ahead. Designate a sober driver or call a cab. But whatever you do, dont drink and drive. The California Office of Traffic Safety DDVIP (Designated Driver VIP) mobile app is now available for free download on iOS and Android devices. Launched last year, the new DDVIP app offers enhanced features, allowing users to Map a Spot with their current location to find DDVIP partnering establishments in their area or a List of Spots to search all participating bars and restaurants throughout California. Users will be offered free incentives at each bar to celebrate their life saving role. They can stay up-to-date with the latest from DDVIP and see what other users are saying via its social tab. Also through the app, for those who want to imbibe but also make it a point to plan ahead, users can easily order a sober ride from Uber, Lyft or Curb all from one screen.

Recent statistics reveal that 30 percent of drivers in fatal crashes had one or more drugs in their systems. A study of active drivers showed more tested positive for drugs that may impair driving (14 percent) than did for alcohol (7.3 percent). Of the drugs, marijuana was most prevalent, at 7.4 percent, slightly more than alcohol. Everyone should be mindful that if youre taking medication whether prescription or over-the-counter drinking even small amounts of alcohol can greatly intensify the impairment affects.

So this August and year-round, remember that theres no excuse for drunk or impaired driving. If you choose to break the law, police sheriff and CHP officials will see you before you see them. *Drive Sober or Get Pulled Over.*

The San Jose Police Department is currently investigating the City's fifth officer-involved shooting of 2015. On Sunday, August 9, 2015, at approximately 6:21 P.M., officers responded to a report of a stabbing in the area of Virginia Avenue and S. 34th Street. Officers arrived on scene and located an adult male suffering from several stab wounds. The victim was transported to a local area hospital and treated for life threatening injuries. The adult suspect fled on foot and got into a vehicle. The suspect vehicle collided with several cars and was abandoned in the area of Kammerer Avenue and Sunset Avenue.

Police Chief Larry Esquivel Announces Intention to Retire in January 2016

SAN JOSE, Calif. San Jose Police Chief Larry Esquivel announced today that he intends to retire effective January 16, 2016, after 30 years of service to the San Jose Police Department. He has served as chief since January 2013.

"It's been an incredible journey over the past three decades, and I couldn't imagine being anywhere else but here as a member of San Jose Police Department," said Esquivel. "It has been an honor to serve and protect while wearing this badge, and I will forever be thankful for the support given to this department and me. We have incredibly talented men and women at SJPD that we can be extremely proud of.



"After thirty years, however, I feel it's time for the next generation to lead, which will open up leadership opportunities for others. I'm confident we're now on the right path toward stability and growth under our current leadership teams, and I know I'm leaving our department in very capable hands."

For the past three decades Chief Esquivel has served in almost every function of law enforcement as he was promoted through the SJPD ranks. He was hired as a police reserve officer in 1984 and was appointed as a sworn police officer in January 1986. Over his career he has worked in patrol, narcotics enforcement, Special Operations - MERGE Unit, investigations, field training, internal affairs, and administration.

"In the face of daunting challenges, Chief Esquivel's strong leadership and commitment to collaboration has steered our police department to keep our residents safe -- with the lowest rate of violent crime of any major city in America during some very difficult years for a workforce that lost hundreds of officers," said San Jose Mayor Sam Liccardo.

"He will be missed. I congratulate and thank Larry for his long, successful career in service to the people of San Jose."

Esquivel was promoted to sergeant in 1997, lieutenant in 2005, and captain in 2010 when he served as Foothill Division Commander. He became a deputy chief in 2011 and was appointed Acting Chief of Police upon the retirement of former Chief Chris Moore in January 2013. He was officially confirmed as Chief of Police in December 2013.

"The past several years have been among the most challenging in the Department's history, and Chief Esquivel has provided strong and collaborative leadership to guide the men and women who serve and protect our community and to achieve greater stability for the Department in the face of daunting difficulties," said City Manager Norberto Dueas.

"Throughout his career and the many years I've known him, Larry has served as an excellent role model in the department, and he has earned the respect and trust from his fellow officers and our community while he opened productive communications channels, encouraged new ideas, and inspired top performance."

Dueas also announced that he will name Assistant Chief Eddie Garcia to serve as Interim Chief after Esquivel steps down next January. Chief Garcia has served with the Department since 1992, and he has been Assistant Chief since January 2013.

"I'm confident both Larry and Eddie and their management team will continue to provide stability, continuity, and effective leadership to guide the department effectively during this transition," he said.



During his career with SJPD, Garcia has worked in patrol, narcotics enforcement, Special Operations/MERGE, community services and investigations. He became Deputy Chief in 2011 and led both the Bureau of Investigations and Bureau of Administration.

Under Esquivel's leadership as chief over the past several years, San Jose Police Department has made notable achievements that include:

- Establishment and expansion of the Community Service Officers Program, which created a new civilian classification and an entire program from the ground up to assist sworn officers by responding to and investigating lower priority calls for service, so police officers are available to respond to higher priority emergency calls and have more time for proactive enforcement.
- Expansion to Three Annual Police Academies. The Department began a new service delivery model for recruit training by partnering with the South Bay Public Safety Regional Training consortium to provide a POST-certified Academy, and starting this year three academies will occur annually.
- Repurposing and opening of the South San Jose Police Substation to address operational needs of the Department and reduce costs by relocating the Training Unit, provide space for the additional Police Academy and the new Community Service Officer program, and facilitate Department fleet needs.
- Launch of the Residential Security Camera Registry that enables residents and business owners to register the locations of their private video surveillance systems so that when a crime occurs, police can identify the locations of nearby cameras and enlist community assistance to help officers collect video evidence and follow up on leads.
- Development of the Body-Worn Camera Pilot Program in collaboration with the San Jose Police Officers Association to prepare comprehensive body-worn camera policies and procedures, and to evaluate equipment and systems leading to possible grant funding, procurement and implementation in the coming year.
- Adoption of a Language Access Plan that guides the Department in providing reasonable steps for working with persons with limited English proficiency and providing timely and meaningful access to available programs, services and benefits.
- Creation of the first Youth Leadership Academy to provide San Jose teens with skills necessary to prepare them to become leaders within our community and teach them valuable lessons for working with the community and the criminal justice system. The TEAM Kids Program also was created for elementary schools to build positive relationships among police officers, students, staff, and parents. The primary goal of the program is to support crime prevention and youth safety with an emphasis on gang prevention education.
- Formation of the Gang Suppression Unit staffed with highly trained officers that focuses enforcement efforts on criminal gang violence while collaborating with community and the Mayor's Gang Prevention Task Force stakeholders.
- Re-established the SJPD Internship Program that provides the opportunity for college students to personally grow and gain an understanding of the law enforcement profession with San Jose Police Department. The program complements the SJPD Community Policing Strategy, and currently more than 30 interns are serving throughout the Department and are receiving training and exposure to many facets of law enforcement.

The policy is comprehensive and addresses the privacy of both officers and individuals.



Ongoing feedback will help shape future revisions of the BWC policy. The BWC Field Test will begin on July 20th and run through

October of this year. Fifteen (15) officers volunteered to field test and evaluate three (3) types of camera systems. The cameras represent different features available on the market as well as different evidence management systems.

San Jose Police Department Targets Impaired Drivers With Sobriety/Drivers License Checkpoint

San Jose, California Friday, June 12, 2015

8:00 PM to 2:00 AM

San Jose, CA -- San Jose Police Department Traffic Unit will be conducting a DUI/Drivers License Checkpoint on Friday, June 12, 2015, at an undisclosed location within the city, between the hours of 8:00 p.m. to 2:00 a.m.

The deterrent effect of DUI checkpoints is a proven resource in reducing the number of persons killed and injured in alcohol or drug involved crashes. Research shows that crashes involving an impaired driver can be reduced by up to 20 percent when well-publicized DUI checkpoints and proactive DUI patrols are conducted routinely.

In California, this deadly crime led to 802 deaths in 2012 because someone failed to designate a sober driver. Nationally, the latest data shows nearly 10,000 were killed by an impaired driver. Over the course of the past three years, DUI collisions have claimed 8 lives and resulted in injury crashes harming 462 of our friends and neighbors, said Sgt Steve Payne.

Officers will be looking for signs of alcohol and/or drug impairment with officers checking drivers for proper licensing delaying motorists only momentarily. When possible, specially trained officers will be available to evaluate those suspected of drug-impaired driving. Recent statistics reveal that 30 percent of drivers in fatal crashes had one or more drugs in their systems. A study of active drivers showed more tested positive for drugs that may impair driving (14 percent) than did for alcohol (7.3 percent). Of the drugs, marijuana was most prevalent, at 7.4 percent, slightly more than alcohol.

According to the National Highway Traffic Safety Administration (NHTSA), checkpoints have provided the most effective documented results of any of the DUI enforcement strategies, while also yielding considerable cost savings of \$6 for every \$1 spent. Nearly 90 percent of California drivers approve of DUI checkpoints.

DUI Checkpoints are placed in locations based on collision statistics and frequency of DUI arrests affording the greatest opportunity for achieving drunk and drugged driving deterrence. Locations are chosen with safety considerations for the officers and the public.

Drivers caught driving impaired can expect the impact of a DUI arrest to include jail time, fines, fees, DUI classes, other expenses that can exceed \$10,000 not to mention the embarrassment when friends and family find out.

Funding for this checkpoint is provided to San Jose Police Department by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration, reminding everyone to Report Drunk Driver Call 9-1-1.
