**San Jose:** On Friday, August 12, 2016, at 12:07 AM, San Jose Police Department officers responded to the area of northbound Hwy 101 and northbound Hwy 280 connector on a report of a dead body. ### (August 9, 2016)

The San Jose Police Department (SJPD) is continuing to ask the public for help to identify and locate the suspect(s) responsible for shooting at occupied vehicles. Since July 5, 2016, SJPD has identified six additional incidents involving shootings at occupied vehicles on or near the Blossom Hill Road corridor. In each of the six new shooting incidents no one reported being injured.

SJPD has dedicated a significant amount of police personnel to conduct follow-up investigation to determine the source of the gunfire. Officers have canvassed the area and distributed flyers to residents asking for help and information. Detectives continue to conduct interviews, collect evidence and analyze data in hopes of identifying the suspect(s).

**San Jose:** The San Jose Police Department's Robbery Unit is asking for the public's help identifying and locating Carjacking suspects. On July 18, 2016 at approximately 6:25 A.M., a stolen vehicle and assault with a deadly weapon (vehicle) occurred at 940 Deer Meadow Court in San Jose. The victim left her vehicle unattended in the driveway while warming up. The victim saw the suspect driving away in her vehicle. The victim got in front of the vehicle and the suspect struck her while fleeing the scene. The victim suffered non-life-threatening injuries and was treated at a local area hospital.

Moments before the carjacking, a grey colored Lexus sedan was seen in the area by a surveillance camera **(video link attached below).** Footage showed the vehicle park in a stall and female driver exit, along with a male passenger (wearing a red shirt). They were seen walking around attempting to open vehicles in the parking lot. During the carjacking, the Lexus sedan was seen speeding away just behind the victim vehicle. The two individuals in the video are considered accomplices to the carjacking. The suspect who took the victim's vehicle was only described as a White or Hispanic male adult.

**San Jose:** On Saturday, February 20, 2016 at approximately 9:31 P.M., officers responded to the area of Camden Avenue and Hicks road on a report of two vehicles involved in a collision. Upon arrival, officers located two vehicles in the roadway with major damage. An adult female (Morse) was pronounced deceased at the scene and a second person (Durbin) was transported to a local area hospital where he passed away.

The San Jose Police Department Traffic Investigation Unit conducted extensive follow up investigation and identified suspect Allen as the person responsible for the death of the two victims. The case was submitted to the Santa Clara County District Attorney's Office who filed double homicide charges on the suspect due to the circumstances of the collision.

San Jose, CA -- San Jose Police Department Traffic Unit will be conducting a DUI/Drivers License Checkpoint on Friday, July 29, 2016, at an undisclosed location within the city limits between the hours of 9:00 p.m. to 3:00 a.m.

The deterrent effect of DUI checkpoints is a proven resource in reducing the number of persons killed and injured in alcohol or drug involved crashes. Research shows that crashes involving an impaired driver can be reduced by up to 20 percent when well-publicized DUI checkpoints and proactive DUI patrols are conducted routinely. DUI Checkpoints are placed in locations based on collision statistics and frequency of DUI arrests, affording the greatest opportunity for achieving drunk and drugged driving deterrence. Locations are chosen with safety considerations for the officers and the public.

In California, this deadly crime led to 867 deaths and over 23,000 serious injuries in 2013 because someone failed to designate a sober driver. Nationally, the latest data shows nearly 10,000 were killed by an impaired driver.

Officers will be looking for signs of alcohol and/or drug impairment with officers checking drivers for proper licensing delaying motorists only momentarily. When possible, specially trained officers will be available to evaluate those suspected of drug-impaired driving, which now accounts for a growing number of impaired driving crashes.

Recent statistics reveal that 30 percent of drivers in fatal crashes had one or more drugs in their systems. A study of active drivers showed more tested positive for drugs that may impair driving (14 percent) than did for alcohol (7.3 percent). Of the drugs, marijuana was most prevalent, at 7.4 percent, slightly more than alcohol. Everyone should be mindful that if you're taking medication – whether prescription or over-the-counter – drinking even small amounts of alcohol can greatly intensify the impairment affects.

Law Enforcement emphasizes the preventable nature of drunk driving reminding everyone that all it takes is a little planning ahead. Designate a sober driver or call a cab. But whatever you do, don't drink and drive. The California Office of Traffic Safety DDVIP

(Designated Driver VIP) mobile app is now available for free download on iOS and Android devices. Launched last year, the new DDVIP app offers enhanced features, allowing users to "Map a Spot" with their current location to find DDVIP partnering establishments in their area or a "List of Spots" to search all participating bars and restaurants throughout California. Users will be offered free incentives at each bar to celebrate their life saving role. They can stay up-to-date with the latest from DDVIP and see what other users are saying via its social tab. Also through the app, for those who want to imbibe but also make it a point to plan ahead, users can easily order a sober ride from Uber, Lyft or Curb – all from one screen.

Drivers caught driving impaired can expect the impact of a DUI arrest to include jail time, fines, fees, DUI classes, other expenses that can exceed \$10,000 not to mention the embarrassment when friends and family find out.

Funding for this checkpoint is provided to San Jose Police Department by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration, reminding everyone to Report Drunk Driver Call 9-1-1.

San Jose: On December 15, 2015, the California Department of Justice (DOJ) implemented Assembly Bill 371 (AB371) which required California Pawn Brokers and Secondhand Dealers to utilize a California Pawn and Secondhand Dealer System, also known as "CAPSS." Many of the San Jose based Pawn Brokers and Secondhand Dealers have not been complying with DOJ and the City's enforceable Municipal Codes.

In the last year, the City of San Jose has experienced an increase of commercial burglary cases. Some property stolen during these crimes were being sold on eBay accounts that are run by certain Secondhand Dealers.

In January 2016, the San Jose Police Department's Burglary Unit created a Pawn Broker / Secondhand Dealer task force to actively monitor and enforce current laws, slow down or inhibit the selling of stolen property from both commercial and residential burglaries,

and to train the business owners on the current compliance requirements.

The San Jose Police Department task force worked closely with the Regional Enforcement Allied Computer Team (REACT) on three major cases related to suspect Roohparvar involving \$712,000.00 of stolen property. Suspect Roohparvar is the business owner of "Silicon Valley Liquidate," also known as, "Compucycle" or "US Tech," located at 876 The Alameda in San Jose. Roohparvar conducts his business as a second hand dealer which requires a permit from the City of San Jose and a license from DOJ. However, Roohparvar was not in compliance with these requirements.

The case was presented to the Santa Clara County District Attorney's Office and Roohparvar was subsequently charged with 6 counts of Possession of Stolen Property and 5 counts of Acquiring Stolen Property for the Purpose of Selling for Financial Gain.

On Thursday, May 19, 2016, the San Jose Police Department's Pawn/Secondhand Dealer task force arrested suspect Roohparvar at his business. Roohparvar was booked into the Santa Clara County Jail on noted charges.

San Jose, CA -- San Jose Police Department Traffic Unit will be conducting a DUI/Drivers License Checkpoint on Friday, May 27, 2016, at an undisclosed location within the city limits between the hours of 9:00 p.m. to 3:00 a.m.

The deterrent effect of DUI checkpoints is a proven resource in reducing the number of persons killed and injured in alcohol or drug involved crashes. Research shows that crashes involving an impaired driver can be reduced by up to 20 percent when well-publicized DUI checkpoints and proactive DUI patrols are conducted routinely. DUI Checkpoints are placed in locations based on collision statistics and frequency of DUI arrests, affording the greatest opportunity for achieving drunk and drugged driving deterrence. Locations are chosen with safety considerations for the officers and the public.

In California, this deadly crime led to 867 deaths and over 23,000 serious injuries in 2013 because someone failed to designate a sober driver. Nationally, the latest data shows nearly 10,000 were killed by an impaired driver.

Officers will be looking for signs of alcohol and/or drug impairment with officers checking drivers for proper licensing delaying motorists only momentarily. When possible, specially trained officers will be available to evaluate those suspected of drug-impaired driving, which now accounts for a growing number of impaired driving crashes.

Recent statistics reveal that 30 percent of drivers in fatal crashes had one or more drugs in their systems. A study of active drivers showed more tested positive for drugs that may impair driving (14 percent) than did for alcohol (7.3 percent). Of the drugs, marijuana was most prevalent, at 7.4 percent, slightly more than alcohol. Everyone should be mindful that if you're taking medication – whether prescription or over-the-counter – drinking even small amounts of alcohol can greatly intensify the impairment affects.

Law Enforcement emphasizes the preventable nature of drunk driving reminding everyone that all it takes is a little planning ahead. Designate a sober driver or call a cab. But whatever you do, don't drink and drive. The California Office of Traffic Safety DDVIP

(Designated Driver VIP) mobile app is now available for free download on iOS and Android devices. Launched last year, the new DDVIP app offers enhanced features, allowing users to "Map a Spot" with their current location to find DDVIP partnering establishments in their area or a "List of Spots" to search all participating bars and restaurants throughout California. Users will be offered free incentives at each bar to celebrate their life saving role. They can stay up-to-date with the latest from DDVIP and see what other users are saying via its social tab. Also through the app, for those who want to imbibe but also make it a point to plan ahead, users can easily order a sober ride from Uber, Lyft or Curb – all from one screen.

Drivers caught driving impaired can expect the impact of a DUI arrest to include jail time, fines, fees, DUI classes, other expenses that can exceed \$10,000 not to mention the embarrassment when friends and family find out.

Funding for this checkpoint is provided to San Jose Police Department by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration, reminding everyone to Report Drunk Driver Call 9-1-1.

## New "Coast to Coast" Seat Belt Enforcement Effort Aims to Increase *Click It or Ticket* Participation, Save Lives

San Jose, CA – From May 23 to June 5, 2016, local law enforcement personnel will participate in the national *Click It or Ticket* campaign in an effort to save lives through increased seat belt use. This education enforcement period comes ahead of the Memorial Day holiday, one of the busiest travel weekends of the year.

According to research conducted by the National Highway Traffic Safety Administration, while 88.5 percent of passenger vehicle occupants buckled up in 2015, almost 50 percent of occupants of fatal crashes nationwide are not restrained. In some states, the rate is as high as 70 percent unrestrained in fatal crashes. In California, more than a half million people travel our roadways at grave risk without proper restraints. These facts gravely highlight the need for increased education, awareness and enforcement and awareness of seat belt use.

This year, NHTSA is aiming to increase campaign participation even more by coordinating a "Coast to Coast" seat belt education and enforcement effort with the California Highway Patrol and law enforcement around the I-10, I-40, I-70 and I-80 corridors. Additionally, law enforcement agencies statewide are joining the Click It or Ticket effort to emphasize the "Coast to Coast" seat belt safety awareness campaign in all 50 states.

"As law enforcement, we have a special role in helping protect the safety of our citizens, from the East to the West Coast," said Acting Lieutenant Steve Payne, San Jose Police Department. "Time after time, we see the deadly results that come from drivers and passengers refusing to wear a seat belt. Wearing a seat belt is one of the most important steps in increasing survivability in a crash. Our job is to educate those who are not buckled up, and to keep them from repeating this potentially deadly mistake."

In 2014, nearly half of the 21,022 passenger vehicle occupants killed in crashes nationally were unrestrained, according to NHTSA. During the nighttime hours of 6 p.m. to 5:59 a.m., that number increased to 57 percent of those killed. Law enforcement agencies will write citations day and night, with a zero-tolerance approach.

"Hundreds of thousands of citizens will be traveling this Memorial Day weekend, as well as throughout the summer vacation season. We want to make sure that people are buckling up to keep themselves and their families safe. It is the greatest defense in a vehicle crash," said Rhonda Craft, Director of the California Office of Traffic Safety.

The San Jose Police Department has implemented a new web-based crime mapping service called "**CrimeMapping.com**," making San Jose crime data available to the public via the web, email alerts and a free mobile web application. This service extracts crime incident data on a regular basis from the Department's records system so that the information being viewed through a Web browser is the most accurate and up to date available.



Any resident with access to the internet can map out and analyze recent crime activity in their neighborhood. CrimeMapping.com also offers free Crime Alerts which help keep the

community well informed by distributing incident reports via e-mail to anyone who subscribes to the system.

The Website and the free mobile web application allow residents to see a map of recent crime activity near an address — such as a residence, place of business, or school. Members of the community can select crime types and date ranges in order to generate reports. They can also receive e-mail updates in the form of crime alerts.

Previous online crime mapping services published by the Department displayed Computer-aided Dispatch (CAD) data which represented preliminary information based on 9-1-1 calls as well as the caller's location. Crimemapping.com data is based on incident reports from the Records Management System (RMS) and is further refined, classified and located at the incident location.

Keeping the public well informed has been proven effective in reducing crime. The San Jose Police Department understands the value of data transparency as well as community-oriented policing. By empowering the community to access crime information in their neighborhood, the Department hopes to further strengthen the police-community partnerships that remain a vital cornerstone of the Department's Community Policing philosophy.

#### San Jose PD Announces CIT Training For All Sworn Personnel

#### **Press Release**

San Jose, Calif.- The San Jose Police Department (SJPD) announces mandatory Crisis Intervention Team (CIT) training for all sworn personnel.

The SJPD's 40-hour CIT Academy was implemented in 1999. CIT officers are trained to respond to calls for service involving individuals who are known to be or are possibly suffering from a mental illness. The basic goals of the program are to improve officer safety, the safety of the consumers (individuals suffering from a mental illness), and to redirect consumers from the judicial system to the health care system via referrals when appropriate.

The CIT program also aims to give the officer an understanding of the particular challenges of those in the mental health community in an effort to equip the officer with tools to possibly deescalate crisis situations. The ultimate goal is to resolve situations involving individuals with mental illnesses by connecting them and their families to services whenever possible.

Nationally, and here in San Jose, there has been a significant rise of untreated and at risk consumers trying to manage their symptoms without professional care. This has created a need for more CIT trained personnel. Currently, the Department has approximately 350 CIT officers, but not all of these officers work in a patrol capacity where such expertise is needed. In order to meet the increasing need for CIT officers, mandatory training will be implemented for all sworn personnel. It is anticipated that three CIT academies will be held per year. The first mandatory CIT Academy is scheduled for September 2016.

The CIT Program is a collaborative effort between the SJPD, the National Alliance for the Mentally III (NAMI), and the Santa Clara County Mental Health Department.

Chief Eddie Garcia said, "This training will enhance the safety of both our officers and individuals suffering from mental illness. We want to give our officers the tools necessary to deal with these situations in an effort to safely diffuse possible confrontations."

"Quite simply, this type of training can help save lives and I'd like to thank the Chief for making sure that all of our officers are equipped with crisis intervention skills," said Mayor Sam Liccardo. "This is another step we can take to ensure that the San Jose Police Department remains the most trusted, professional and well-trained police force in the country."

San Jose, CA — On April 30 from 10 a.m. to 2 p.m. the SJPD and the Drug Enforcement Administration (DEA) will give the public its 11th opportunity in six years to prevent pill abuse and theft by ridding their homes of potentially dangerous expired, unused, and unwanted prescription drugs. Bring your pills for disposal to any of the 4 sites listed below (The DEA cannot accept liquids or needles or sharps, only pills or patches.) The service is free and anonymous, no questions asked.

Last September, Americans turned in 350 tons (over 702,000 pounds) of prescription drugs at more than 5,000 sites operated by the DEA and more than 3,800 of its state and local law enforcement partners. Overall, in its 10 previous Take Back events, DEA and its partners have taken in over 5.5 million pounds—more than 2,750 tons—of pills.

This initiative addresses a vital public safety and public health issue. Medicines that languish in home cabinets are highly susceptible to diversion, misuse, and abuse. Rates of prescription drug abuse in the U.S. are alarmingly high, as are the number of accidental poisonings and overdoses due to these drugs. Studies show that a majority of abused prescription drugs are obtained from family and friends, including from the home medicine cabinet. In addition, Americans are now advised that their usual methods for disposing of unused medicines—flushing them down the toilet or throwing them in the trash—both pose potential safety and health hazards.

The San Jose Police Department is currently investigating a Homicide. On July 29, 2014 at approximately 2:15 A.M., San Jose Police "911" Call Center received information about a person being physically attacked by a group of suspects in the area of South Market Street and Park Avenue in Downtown San Jose. Upon arrival officers located an adult male suffering from multiple stab wounds. The victim, later identified as 33 year old Michael Maynard, was transported to a local area hospital where he was pronounced deceased a short time later.

After extensive follow up investigation, homicide detectives identified and arrested three suspects in connection with the murder of Michael Maynard.
