#### Update: 1-5-17

Follow-up investigation by Homicide detectives lead to the identification of additional suspects involved in the murder of victim Bolivar Leyva. Warrants were obtained and on January 3, 2017, San Jose Police Department's Covert Response Unit arrested David Mendivil for Accessory After The Fact - 32 PC, Matthew Mendivil for Murder - 187 PC, and Paul Lozano for Murder - 187 PC.

On January 4, 2017, San Jose Police Department's Covert Response Unit arrested Esaias Valles for Murder - 187 PC.

All suspects were booked into the Santa Clara County Jail on noted charges.

<u>Note:</u> The original press release indicated Suspect Alexander Lozano was arrested, however charges were not filed. As a result of the follow up investigation, Suspect Lozano was charged with Murder - 187 PC while he was in custody in the Santa Clara County Jail on other charges.

**San Jose, Calif.** - The San Jose Police Department's Robbery Unit has been investigating a series of at least fourteen (14) purse snatch style robberies which have occurred between October 2016 through December 2016. The robberies involved older/elderly Asian females being targeted at shopping centers and/or stores.

The female victims were followed home where the suspect approached them and committed the purse snatch robbery. On several occasions, the victims were pulled to the ground and/or dragged during the struggle, causing injuries. On some of the robberies, a firearm was seen or threatened by the suspect.

A silver Jeep Patriot SUV was used in this robbery string. The suspect in these robberies was typically wearing a hooded sweatshirt, and described as a thin build, light-skinned black male or a Hispanic male.

Terrell Anthony Norman, DOB: 9-9-98, was identified as a suspect. On 12-22-16, MERGE officers arrested Norman in the area of Quimby Rd. and White Rd. in San Jose. Norman was booked into the Santa Clara County Jail for multiple counts of robbery.

The San Jose Police Department has arrested a suspect in connection with the attempted homicide of two San Jose Police Officers. On Thursday, November 17, 2016, at approximately 6:40 AM, the San Jose Police Department's Covert Response Unit located and arrested 20 year old Luis Soriano in San Jose. Suspect Soriano was booked into the Santa Clara County Jail for two counts of attempted homicide of a police officer and probation violation.

The San Jose Police Department is confident we have the person responsible for this reprehensible act of violence on our officers. The identification and arrest of suspect Soriano was made possible as a result of extraordinary follow up investigations by the San Jose Police Department's Gang Investigations Unit, Violent Crimes Enforcement Team, Homicide Unit, Robbery Unit, Special Investigations Unit, METRO Unit, Covert Response Unit and the MERGE Unit. In addition, the community's participation proved to be invaluable. Lastly, the contributions from the Santa Clara County Probation Department and the Santa Clara County District Attorney's Office strengthened our investigative efforts that led to a successful resolution.

Chief Eddie Garcia said, "The victim officers who were shot at, came back to work the next day. They realized what had transpired the night before, but unfazed they represented the best of a San Jose Police Officer, put their uniforms on and again went out to protect and guard this community. Much has been made of our staffing levels, but as I've said many times, we will rise again, and as we rise, please do not mistake that because of our issues we are complacent, for your department is amongst the most professional, dedicated and tenacious police departments in the country".

On July 19, 2016, a sexual assault occurred in San Jose. Damou Evans, a Morgan Hill resident, was identified as the suspect and a known Sex Offender. The San Jose Police Department's (SJPD) Megan's Law/290 Team conducted follow-up investigation and subsequently obtained an arrest and search warrant for Evans.

#### SPECIAL TRAFFIC ENFORCEMENT AND CRASH PREVENTION

San Jose, CA — The San Jose Police Department has been awarded a \$300,000 grant from the California Office of Traffic Safety (OTS) for a year-long program of special enforcements and public awareness efforts to prevent traffic related deaths and injuries. San Jose PD will use the funding as part of the city's ongoing commitment to keep our roadways safe and improve the quality of life through both enforcement and education.

"The funds from this grant will allow us to focus more officers on much needed traffic safety," said Acting Lieutenant Steven Payne.

After falling to a ten year low in 2010, the number of persons killed has climbed nearly 17% across the state with 3,176 killed in 2015 according to the National Highway Traffic Safety Administration. Particularly alarming is the six year rise in pedestrian and bicycle fatalities, along with the growing dangers of distracting technologies, and the emergence of drug-impaired driving as a major problem. This grant funding will provide opportunities to combat these and other devastating problems such as drunk driving, speeding and crashes at intersections.

"Years of research tell us that enforcement and education work best jointly to combat unsafe driving. This grant brings both tactics together, with the Office of Traffic Safety and the San Jose Police Department working in concert to help keep the streets and highways safe across San Jose and the state," said OTS Director Rhonda Craft.

Activities that the grant will fund include:

- Educational presentations
- DUI checkpoints
- DUI saturation patrols
- Bicycle and pedestrian safety enforcement
- Motorcycle safety enforcement
- Distracted driving enforcement
- Seat belt and child safety seat enforcement

- Speed, red light, and stop sign enforcement
- Warrant service operations targeting multiple DUI offenders
- Sompilation of DUI "Hot Sheets," identifying worst-of-the-worst DUI offenders
- Specialized DUI and drugged driving training such as Standardized Field Sobriety Testing (SFST), and Advanced Roadside Impaired Driving Enforcement (ARIDE).

Funding for this program is from the California Office of Traffic Safety through the National Highway Traffic Safety Administration.

One of the officers had just entered his patrol vehicle when he spotted the stolen vehicle traveling in his direction. The vehicle was occupied by the lone driver (see description below). The suspect vehicle reversed direction into a cul-de-sac. The officer initiated a high risk car stop on the stolen vehicle. Instead of complying, the driver of the stolen vehicle accelerated and drove head into the officer's vehicle.

The stolen vehicle went into reverse, struck a parked semi-truck trailer, and accelerated towards the officer a second time. At this time, two other officers at the scene fired their service weapons at the suspect in defense of the victim officer's life. The suspect was able to escape. The victim officer was transported to a local hospital suffering minor injuries and was subsequently released.

A short time later, the suspect vehicle was located unoccupied approximately 1 mile away in the area of McKee Rd. and El Rancho Verde Dr. Patrol and K9 officers located a person hiding nearby. This person was taken into custody without incident. He had an outstanding misdemeanor warrant for Resisting Arrest. After preliminary interviews, investigators determined he was not involved in the shooting. This suspect was booked into the Santa Clara County Jail for the outstanding warrant.

The suspect is described as a Hispanic male, between 20 and 30 years old. At this time, it does not appear the suspect was injured in the confrontation and area hospitals were checked for walk in shooting victims - none were found.

All three officers were placed on routine paid administrative leave. The San Jose Police Department's Homicide Unit is conducting the criminal investigation. The case is being monitored by the San Jose Police Department's Internal Affairs Unit, the City Attorney's Office, and the Office of the Independent Police Auditor.

**San Jose, CA** – On Saturday, October 22, 2016, from 10:00 a.m. to 2:00 p.m., the San Jose Police Department and the Drug Enforcement Administration (DEA) will give the public its 15th opportunity in six years to prevent pill abuse and theft by ridding their homes of potentially dangerous expired, unused, and unwanted prescription drugs. **Note:** The DEA cannot accept liquids, needles or sharps - only pills or patches. The service is free and anonymous, no questions asked!

Last April, Americans turned in 447 tons (over 893,000 pounds) of prescription drugs at almost 5,400 sites operated by the DEA and more than 4,200 of its state and local law enforcement partners. Overall, in its 11 previous Take Back events, DEA and its partners have taken in over 6.4 million pounds - about 3,200 tons of pills.

This initiative addresses a vital public safety and public health issue. Medicines that languish in home cabinets are highly susceptible to diversion, misuse, and abuse. Rates of prescription drug abuse in the U.S. are alarmingly high, as are the number of accidental poisonings and overdoses due to these drugs. Studies show that a majority of abused prescription drugs are obtained from family and friends, including from the home medicine cabinet. In addition, Americans are now advised that their usual methods for disposing of unused medicines - flushing them down the toilet or throwing them in the trash - both pose potential safety and health hazards.

Students will be walking and biking to school along with parents, teachers and community leaders. Members of the San Jose Police Department will be deploying traffic/patrol officers to the neighborhoods near schools to enforce traffic laws, reminding everyone the importance of pedestrian and bicycle safety this day and every day represents.

Events are planned for Wednesday, October 5<sup>th</sup>, with students, parents and community leaders walking/biking to school.

Walk to School Day events raise awareness of the need to create safer routes for walking and bicycling. It also emphasizes the importance of issues such as increasing physical activity among children, pedestrian safety, traffic congestion and concern for the environment. The events build connections between law enforcement, families, schools and the broader community.

### Important Safety Reminders

### For Pedestrians:

- Walk on a sidewalk or path when one is available.
- If no sidewalk or path is available, walk on the shoulder, facing traffic.
- Stay alert; don't be distracted by electronic devices, including smart phones, MP3 players, and other devices that take your eyes (and ears) off the road.

- Be cautious night and day when sharing the road with vehicles. Never assume a driver sees you (he or she could be distracted, under the influence of alcohol and/or drugs, or just not see you). Make eye contact with drivers as they approach.
- Be predictable. Cross streets at crosswalks or intersections when possible. This is where drivers expect pedestrians.
- If a crosswalk or intersection is not available, locate a well-lit area, wait for a gap in traffic that allows you enough time to cross safely, and continue to watch for traffic as you cross.
- Be visible. Wear bright clothing during the day, and wear reflective materials or use a flash light at night.

### For Drivers:

- Look for pedestrians everywhere. Pedestrians may not be walking where they should be or may be hard to see—especially in poor lit conditions, including dusk/dawn/night and poor weather.
- Always stop for pedestrians in the crosswalk or where pedestrian crosswalk signs are posted.
- Never pass vehicles stopped at a crosswalk. They may be stopped to allow pedestrians to cross the street.
- Slowdown and look for pedestrians. Be prepared to stop when turning or otherwise entering a crosswalk.
- Never drive under the influence of alcohol and/or drugs.
- Follow the speed limit; slow down around pedestrians.
- Stay focused and slow down where children may be present, like school zones and neighborhoods.

"I commend the San Jose Police Department for their exceptional work to arrest an extremely dangerous suspect without any loss of life --- our officers continue to exceed expectations at a time when they remain historically shorthanded," said Mayor Sam Liccardo.

**San Jose, CA -** The San Jose Police Department Financial Crimes Unit has been conducting a year long investigation into an East Palo Alto criminal street gang committing burglaries in the City of San Jose. More than 13 gang members were identified as being part of this burglary crew.

Since 2015, this crew has been responsible for over two hundred residential burglaries in San Jose and other neighboring jurisdictions. High end vehicles (ie: Porsche, BMW, Mercedes, etc) were commonly used during the commission of those burglaries. Items stolen have included: firearms, cash, jewelry, electronics, etc.

On 08/31/16, with the assistance from the San Mateo County Sheriff's Office. Santa Clara County Sheriff's Office, Daly City Police Department, East Palo Alto Police Department, Newark Police Department, Union City Police Department, Milpitas Police Department, Redwood City Police Department, North County Regional SWAT team and U.S. Postal Inspector a total of 8 search and arrest warrants were served in the City of East Palo Alto and Newark. Over 150 officers from various outside agencies participated in the operation in addition to San Jose Police personnel. Seized items included stolen property, large amounts of cash, a firearm, burglary tools, and ski masks. Seven suspects were taken into custody and booked on multiple burglary counts and a gang enhancement.

San Jose, CA -- San Jose Police Department Traffic Unit will be conducting a DUI/Drivers License Checkpoint on Thursday, September 1, 2016, at an undisclosed location within the city limits between the hours of 9:00 p.m. to 3:00 a.m.

The deterrent effect of DUI checkpoints is a proven resource in reducing the number of persons killed and injured in alcohol or drug involved crashes. Research shows that crashes involving an impaired driver can be reduced by up to 20 percent when well-publicized DUI checkpoints and proactive DUI patrols are conducted routinely. DUI Checkpoints are placed in locations based on collision statistics and frequency of DUI arrests, affording the greatest opportunity for achieving drunk and drugged driving deterrence. Locations are chosen with safety considerations for the officers and the public.

In California, this deadly crime led to 867 deaths and over 23,000 serious injuries in 2013 because someone failed to designate a sober driver. Nationally, the latest data shows nearly 10,000 were killed by an impaired driver.

Officers will be looking for signs of alcohol and/or drug impairment with officers checking drivers for proper licensing delaying motorists only momentarily. When possible, specially trained officers will be available to evaluate those suspected of drug-impaired driving, which now accounts for a growing number of impaired driving crashes.

Recent statistics reveal that 30 percent of drivers in fatal crashes had one or more drugs in their systems. A study of active drivers showed more tested positive for drugs that may impair driving (14 percent) than did for alcohol (7.3 percent). Of the drugs, marijuana was most prevalent, at 7.4 percent, slightly more than alcohol. Everyone should be mindful that if you're taking medication – whether prescription or over-the-counter – drinking even small amounts of alcohol can greatly intensify the impairment affects.

Law Enforcement emphasizes the preventable nature of drunk driving reminding everyone that all it takes is a little planning ahead. Designate a sober driver or call a cab. But whatever you do, don't drink and drive. The California Office of Traffic Safety DDVIP

(Designated Driver VIP) mobile app is now available for free download on iOS and Android devices. Launched last year, the new DDVIP app offers enhanced features, allowing users to "Map a Spot" with their current location to find DDVIP partnering establishments in their area or a "List of Spots" to search all participating bars and restaurants throughout California. Users will be offered free incentives at each bar to celebrate their life saving role. They can stay up-to-date with the latest from DDVIP and see what other users are saying via its social tab. Also through the app, for those who want to imbibe but also make it a point to plan ahead, users can easily order a sober ride from Uber, Lyft or Curb – all from one screen.

Drivers caught driving impaired can expect the impact of a DUI arrest to include jail time, fines, fees, DUI classes, other expenses that can exceed \$10,000 not to mention the embarrassment when friends and family find out.

### **Operation Gang of Thrones**

**San Jose, CA -** Since March of 2016, detectives of the San Jose Police Department's (SJPD) Gang Investigations Unit began building a criminal conspiracy investigation against a Vietnamese criminal street gang. SJPD worked closely with the Santa Clara County District Attorney's Office, Drug Enforcement Administration, and Federal Bureau of Investigation.

On Tuesday, August 23, 2016, all the agencies mentioned above, as well as personnel from the Santa Clara County Sheriff's Office, Milpitas Police Department, Santa Clara Police Department, Orange County Sheriff's Office, and the Louisiana State Police, served search warrants and arrest warrants at various locations in the cities of San Jose, Santa Clara, Milpitas, Fremont, Anaheim, and an undisclosed location in the State of Louisiana.

This collaborative investigation resulted in the arrest of 23 suspects who are known members or associates of a criminal street gang in San Jose. The suspects were booked into the Santa Clara County Jail on charges ranging from extortion, public corruption, narcotic trafficking, assault, illegal gun possession, and conspiracy. Two of the suspects were arrested in Anaheim, California, by the Orange County Sheriff's Office. There are 6 suspects at large for various felonies, including; Conspiracy, Accessory After the Fact, Narcotics and Gambling.

A total of 34 search warrants were served during this investigation in California and 1 Louisiana. The following evidence was seized:

- 5 handguns
- 69 illegal gambling machines
- Over \$200,000 in US Currency
- Body armor, jewelry, phones, computers, and financial records
- Investigators also recovered over 4000 Ecstasy pills, 300 Xanax pills, 200 Molly tablets, illegal steroids, over 600 pounds of Marijuana (420 lbs of which was seized by the Louisiana State Police in transit from San Jose)
- Several vehicles were also seized; which included one with a hidden compartment containing \$100,000
- One alligator

During the course of the investigation, SJPD was alerted to the possible criminal involvement of a San Jose Police Officer. Upon

learning this information, SJPD took immediate action by implementing extraordinary investigative measures to determine the extent of the officer's involvement in this criminal investigation.

The investigation revealed that SJPD Officer Derrick Antonio, a 9 1/2 year veteran, was providing confidential law enforcement information to members of a criminal street gang in San Jose. The Santa Clara County District Attorney's Office reviewed the investigation and issued warrants for Officer Antonio's arrest, charging him with 5 felony counts of 502(C)(3) PC - Unauthorized Computer Access and 1 felony count of 32 PC - Accessory After the Fact.

On 8-23-16, Officer Antonio was arrested in the City of San Jose by members of the SJPD's Criminal Investigations Detail. He was booked into the Santa Clara County Jail on the above charges. Officer Antonio has been on paid administrative leave since June 2016.

Lastly, during the course of the investigation, SJPD identified three suspects who conspired to bribe a uniformed member of the SJPD. The suspects are affiliated with the Duong Café, located at 2268 Senter Road in San Jose, and are associated to a criminal street gang in San Jose.

**San Jose:** On Monday, August 15, 2016, at approximately 6:18 PM, officers responded to Regional Medical Center on a report of two males driven to the hospital suffering from at least one gunshot wound each. Victim #1 was pronounced deceased at the hospital. Victim #2's injuries were determined to be non-life-threatening.

Follow-up investigation revealed the shooting occurred on the 200 block of N. White Road as the victims were traveling in a vehicle.
